ORDER

It appears from the Order bearing No. ERC/7-100.4(1)(18).7/2009/1357(4) dated 31.08.2009 issued by the Regional Director, Eastern Regional Committee, National Council for Teacher Education, that in exercise of the powers vested under Clause (a) of Sub – section 3 of Section 14 of National Council for Teacher Education Act, 1993, the Eastern Regional Committee has granted recognition to Majhihira Ashram Primary Teachers' Training Institute, P.O. Majhihira, Dist. Purulia, PIN – 723 128 for conducting Primary Teachers' Training (Diploma-in-Education) Course of two years duration with an annual intake of 50(fifty) students.

The West Bengal Board of Primary Education, being the Examining Body, appointed vide Gazette Notification of the Order dated 23RD October, 2008 issued by the Principal Secretary to the Government of West Bengal, School Education Department, Primary Branch, grants affiliation from the ensuing academic session in terms of said Order to Majhihira Ashram Primary Teachers' Training Institute, P.O. Majhihira, Dist. Purulia, PIN – 723 128, without insisting on the submission of the Gazette Notification of the said order dated 30TH December, 2005 of the Regional Director, Eastern Regional Committee, National Council for Teacher Education as already settled by the Hon'ble Justice Aniruddha Bose, Calcutta High Court in his order dated 23RD April, 2009 in W. P. No. 3613 (W) of 2009 with W. P. No. 3083 (W) of 2009, with W. P. No. 5036 (W) of 2009, with W.P. No. 5027 (W) of 2009, W.P. No. 5028 (W) of 2009, W.P. No. 5051 (W) of 2009 and W.P. No. 5052 (W) of 2009.
